

## GENERAL DES MOINES REGISTER INSIDER SWEEPSTAKES RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

2. **ELIGIBILITY:** Each Sweepstakes is open to legal U.S. residents of the State of Iowa who are 18 years or older at the time of entry unless otherwise stated, and who are current subscribers or Insider members of The Des Moines Register as of the published sweepstakes start date. Employees and contractors of The Des Moines Register (“Sponsor”), Gannett Co., Inc., and each of their subsidiaries and affiliated companies, advertising and promotional agencies, of Second Street, and the immediate family members of, or any person domiciled with, any such employees or contractors are not eligible to enter or win. You are not a winner until you have been notified as a potential winner, your affidavit of eligibility has been verified, and you have complied with all terms of these rules. If you have not activated your subscription to be an Insider Member, follow the instructions on the Insider page to activate your subscription.

Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. Ad blocking software on your computer needs to be disabled so that it doesn’t interfere with processing your entry. Sponsor will not be responsible for incomplete, late, lost, misdirected or illegible entries. By entering, you agree to the terms of these Official Rules and to receive emails from Sponsor or those directed by Sponsor. You may opt-out of receipt of the emails by following the directions in the email. All entries become property of Sponsor and none will be returned. Any questions regarding the number of entries submitted shall be determined by Sponsor in its sole discretion, and Sponsor reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Sweepstakes.

4. **WINNER SELECTION:** Sweepstakes winners will be selected in a random drawing from among all eligible entries received by published Sweepstakes deadline.

5. **PRIZES AND ODDS:** The number of winners, description of prizes, and approximate retail value of prizes are clearly published on the Insider Page. Prizes may be subject to expiration, deadlines, and other conditions and restrictions may apply. Odds of winning depend on the number of qualified entries received.

6. **WINNER NOTIFICATION AND ACCEPTANCE:** Winners will be notified at the telephone number or email address provided on winner’s entry form. Sponsor will contact winner during regular business hours at number provided on entry form and will leave no messages. Failure to reach winner by phone, email notification being undeliverable, or failure of winner to respond to notification, may result in disqualification of winner, forfeiture of his or her interest in all prizes, and selection of a substitute winner from among all remaining eligible entries. To claim prize, each winner must contact Sponsor at 515-284-8562 within five (5) business days after notification. Valid photo identification may be required. Winners may waive their right to receive prizes. Prizes are non-assignable and

nontransferable. No substitutions allowed by winners. Prizes and individual components of prize packages are subject to availability and Sponsor reserves the right to substitute prizes of equal or greater value. Winners are solely responsible for reporting and payment of any taxes on prizes. Winners may be required to complete an affidavit of eligibility/liability and publicity release which must be returned before the prize is awarded. Failure to complete, sign and return the affidavit, or to comply with any term or condition of these Official Rules, may result in a winner's disqualification, the forfeiture of his or her interest in the prize, and the award of the prize to a substitute winner. Guests traveling with the winner will be required to complete a release of liability form. Except where prohibited, acceptance of any prize constitutes winner's consent to the publication of his or her name, biographical information and likeness in any media, including without limitation the internet, for any commercial or promotional purpose without further compensation. **7. PARTICIPATION:** By participating, entrants agree to be bound by these Official Rules and the decisions of Sponsor. Sponsor will not be responsible for incomplete, lost, late, misdirected or illegible entries or for failure to receive entries or other electronic communications due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware, or software, whether originating with sender or Sponsor. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Sweepstakes as solely determined by Sponsor. In the event the Sweepstakes is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor which corrupts or impairs the administration, security, fairness or proper operation of the promotion, Sponsor reserves the right in its sole discretion to suspend, modify or terminate any Sweepstakes at any time. Should a Sweepstakes be terminated prior to the stated expiration date, Sponsor reserves the right to award prizes based on the eligible entries received before the termination date. The authorized account holder of the email address submitted at the time of entry will be considered the entrant. An "authorized account holder" shall mean the natural person assigned to such email account by the internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with such email account. A potential winner may be requested to provide proof that he or she is the authorized account holder of the email address associated with a winning entry. In the event of a dispute, all online entries will be deemed to have been submitted by the owner of the ISP account from which they were sent. For these purposes, an ISP account holder shall mean the natural person assigned to such ISP account by the internet access provider, online service provider or other organization responsible for assigning ISP addresses for the domain associated with such ISP account. Any questions regarding the number of entries or votes submitted by the owner of an ISP account shall be determined by Sponsor in its sole discretion.

**9. CONSTRUCTION:** The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.

**10. DECISIONS AND WINNER NAMES:** The decisions of Sponsor regarding the selection of winners and all other aspects of a Sweepstakes shall be final and binding in all respects. Sponsor will not be responsible for typographical, printing or other inadvertent errors in these Official Rules or in other materials relating to the Sweepstakes.
