

GENERAL THE NEWS JOURNAL INSIDER SWEEPSTAKES RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

2. **ELIGIBILITY:** Each Sweepstakes is open to legal U.S. residents of the State of Delaware who are 18 years or older at the time of entry unless otherwise stated, and who are current subscribers or Insider members of the The News Journal as of the published sweepstakes start date. Employees and contractors of The News Journal (“Sponsor”), Gannett Co., Inc., and each of their subsidiaries and affiliated companies, advertising and promotional agencies, of Second Street, and the immediate family members of, or any person domiciled with, any such employees or contractors are not eligible to enter or win. Ad blocking software on your computer needs to be disabled so that it doesn't interfere with processing your entry. Sponsor will not be responsible for incomplete, late, lost, misdirected or illegible entries. By entering, you agree to the terms of these Official Rules and to receive emails from Sponsor or those directed by Sponsor. You may opt-out of receipt of the emails by following the directions in the email. All entries become property of Sponsor and none will be returned. Any questions regarding the number of entries submitted shall be determined by Sponsor in its sole discretion, and Sponsor reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Sweepstakes.

An "authorized account holder" shall mean the natural person assigned to such email account by the internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with such email account. A potential winner may be requested to provide proof that he or she is the authorized account holder of the email address associated with a winning entry. In the event of a dispute, all online entries will be deemed to have been submitted by the owner of the ISP account from which they were sent. For these purposes, an ISP account holder shall mean the natural person assigned to such ISP account by the internet access provider, online service provider or other organization responsible for assigning ISP addresses for the domain associated with such ISP account. Any questions regarding the number of entries or votes submitted by the owner of an ISP account shall be determined by Sponsor in its sole discretion.
