

**LITTLE SHOP OF HORRORS TICKET SWEEPSTAKES  
OFFICIAL RULES**

**1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

**2. Eligibility.** Subject to the additional restrictions below, the **LITTLE SHOP OF HORRORS TICKET SWEEPSTAKES** (“Sweepstakes”) is open to legal U.S. residents of who are 18 years or older at the time of entry and who are current subscribers or Insider members of the News-Leader. Employees and contractors of the News-Leader (“Sponsor”), Gannett Co., Inc., and each of their respective affiliated companies, or of any their advertising and promotional agencies, of Second Street, and the immediate family members of, and any persons domiciled with, any such employees or contractors, are not eligible to enter or to win.

Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. Ad blocking software on your computer needs to be disabled so that it doesn’t interfere with processing your entry. Sponsor will not be responsible for incomplete, late, lost, misdirected or illegible entries.
